**SECTION A: DEFINITIONS & CONDITIONS**

The present Tariff Book defines the charges payable to THPA for the use of the services and facilities provided at the Conventional Cargo Terminal which relate the handling of cargo.

**1. DEFINITIONS**

1.1 The definitions outlined in Chapter I, Article 1 of the General Conditions shall apply.

**2. APPLICATION**

2.1 The rates to be charged by THPA to its Customers for the Services and/or the Facilities provided by THPA, are categorized as follows:

TARIFF I: GENERAL CARGO

TARIFF II: DRY BULK CARGO

TARIFF III: LIQUID & DRY BULK CARGO WITH PIPELINES

TARIFF IV: WHEELED CARGO VIA RO-RO

TARIFF V: CONTAINERS

TARIFF VI: NON-VESSEL CYCLE OPERATIONS

TARIFF VII: ADDITIONAL SERVICES/VARIOUS CHARGES

TARIFF VIII: WORK DELAYS/CANCELLATION

**3. GENERAL**

3.1 Rates and prices included in each tariff above are for services and operations carried out under normal conditions and during normal working hours.

3.2 All service charges in the present Tariff Book include port service charges and port infrastructure charges.

3.3 All the charges set in the various Tariff Schedules do not include V.A.T.

3.4 The minimum invoiced cargo amount is one (1) metric ton.

3.5 The charges computation is based on the official cargo documents, such as cargo shipping documents (cargo manifest, consignment note, bill of lading etc.), Customs declarations, THPA notes (service notes, tallymen sheets etc.).

3.6 The invoiced quantity for the loading/discharge to/from vessel is based on:

a) on the cargo manifest during discharge or in case of direct discharge (II.1) on THPA weighing notes (when weighing occurs for the cargo in total)

b) during loading on THPA weighing notes (when weighing occurs for the cargo in total) or the customs documents or the loading manifest or the dispatch note.

- 3.7 In case of more than one surcharges or/and discounts for a cargo, their algebraic sum is calculated and then applied on the basic rate.
- 3.8 General cargo discharge/loading operation charges include small cargo transfer/shifting on the quay for operational needs.
- 3.9 The dry bulk discharge charges (directly or through quays) include the cleaning of the vessel holds, for which THPA is obliged to dispose for vessels with cargo up to 3000 tons, up to three (3) dockers, for every 1000 tons over 3000 tons, one (1) docker in addition to the three.
- 3.10 Minimum usage time of mechanical means is one hour. After the first hour, a fraction of an hour less than fifteen (15) minutes is not charged, while a fraction greater than fifteen minutes is charged as one hour.
- 3.11 For vessel discharged cargo, the calculation of storage charges shall commence from the day of completion of the discharging operations.
- 3.12 For vessel loaded cargo, the calculation of storage charges shall be calculated up until the day on which the vessel loading operations start.
- 3.13 For cargoes not related to vessel cycle operations, the calculation of storage charges shall commence from the day of cargo receipt in open or covered areas.
- 3.14 In the occasion that a THPA accredited third party provides any service included herein, the service charge will not exceed the corresponding rate of the present. The Customer's invoicing process will be determined at the accreditation of the third party.
- 3.15 The provision of services at cargoes not described herein is charged on a case-by-case basis.
- 3.16 THPA reserves the right to review and change the present Tariff Book from time to time, subject to pre-notice of one month for new services, and two months for amendment of the Price List.
- 3.17 The original text is in Greek and in the event of any discrepancy or inconsistency between the Greek and the English version, the Greek version shall prevail over the English version.
- 3.18 The acceptance of this pricing policy also constitutes acceptance of the General Terms & Conditions of the Conventional Port, for which the Customer is notified.

- Container handling at the Conventional Port is performed in accordance with the General Terms and Conditions of the Container Terminal, as described in the corresponding book, with the exception of the following terms that apply as set forth in this issue of the General Terms of the Conventional Port:
  - (i) Working hours when the vessel is not transporting exclusively containers.
  - (ii) Operations planning and the corresponding deadlines for submission and cancellation.
- In case that the containers are not delivered with the purpose of directly exiting through the port land gates, THPA shall transfer them to the Container Terminal without previous notification of the Customer.

**2. CHARGES**

Container services provided at the Conventional Port, are charged according to the Container Terminal Tariff Book, excluding the vessel's discharge/loading services with the Ro-Ro system, as described at the General Terms of the Conventional Port.
